

THIS ORDER OF APPOINTMENT dated 1 October 2020 is made by East Suffolk Council (hereinafter called "the District Council") pursuant to s91 of the Local Government Act 1972 (Temporary Appointment of Members of Parish and Community Councils).

WHEREAS

- (1) Sutton Parish Council (hereinafter called "the Parish Council") lies within the administration of the District Council
- (2) The Parish Council is unable to act because there are so many vacancies in the office of parish councillors
- (3) The District Council held an ordinary meeting of the Council on 23 September 2020 to consider a report about temporary appointment to the Parish Council (Paper ES-0490 and relevant minute refer) and agreed at that meeting to appoint persons temporarily to fill the vacancies until other Parish Councillors are elected and have taken up office and to the making of an order under s91 of the Local Government Act 1972 to give effect to their resolution.

SUSAN COLLINS of Redlands, Old Post Office Lane, Sutton, IP12 3JQ is HEREBY APPOINTED to fill a vacancy upon the Parish Council and shall remain so appointed unless and until either sufficient vacancies in the office of parish councillor have been filled so as to enable the Parish Council to act or this order is revoked.

JACKI (JACQUELINE) SCHAFER of Sleepy Hollow, Main Road, Sutton, IP12 3DU is HEREBY APPOINTED to fill a vacancy upon the Parish Council and shall remain so appointed unless and until either sufficient vacancies in the office of parish councillor have been filled so as to enable the Parish Council to act or this order is revoked.

ALAN MCMANUS of 2 old Post Office Cottages, Woodbridge Road, Sutton, IP12 3EA is HEREBY APPOINTED to fill a vacancy upon the Parish Council and shall remain so appointed unless and until either sufficient vacancies in the office of parish councillor have been filled so as to enable the Parish Council to act or this order is revoked.
